#### MINUTES OF THE UK SHARED PROSPERITY FUND TASK & FINISH GROUP

#### **MONDAY 15 MAY 2023**

### 2. Declarations of Interest

### 3. Emerging challenges and opportunities

The group was informed that every year Historic England asks local authorities to appraise whether listed buildings and conservation areas can be assessed as being "at risk" using their assessment criteria. In 2022, Church Green Conservation Area was subject to an appraisal and assessed as meeting the criteria for being at risk. This has been formally recognised by Historic England and the conservation area is now on the Heritage at Risk register. It was hoped that this formal recognition would result in funding being made available to reinstate some of the heritage features but Historic England's funding is allocated to Heritage Action Zones for the next 5 years. The group agreed that it would accept new bids for conservation activities under intervention E1: Improvements to town centres and high streets.

Levels of youth unemployment is identified as a key challenge in the investment plan. Redditch has the second highest rate in the County and the rate is rising. In response to this the borough council has been approached by Worcestershire County Council (WCC) regarding a potential youth hub in the town. The youth hub would be a dedicated facility where young people could access support to address barriers to employment, receive 1-1 advice, employability workshops and training. The proposal is to replicate the model that is successfully delivering support to young people in Worcester city. If the borough council is supportive, WCC will submit a funding bid to DWP but this funding will need to be supplemented with UKSPF monies. WCC submitted a proposal to deliver employment support to young people during the first call for projects. The ambition now is to adapt this

proposal to include a wider range of activities. The funding required from the UKSPF may be reduced if the bid to DWP is successful.

The group were advised that the Worcestershire LEP has commissioned a skills strategy for the borough. The strategy will complement the Local Skills Improvement Plan for Worcestershire which is currently being developed by HW Chamber of Commerce. It is anticipated that the skills strategy will be available in early summer 2023.

The group were advised that, in light of new opportunities, conversations have taken place with other districts who are yet to allocate their People & Skills funding. These have identified opportunities to collaborate with other districts to develop countywide programmes that would benefit from economies of scale, whilst maintaining local delivery. The group were supportive of delaying decisions regarding People & Skills projects until county-wide proposals have been developed and can be considered, alongside existing proposals, with reference to the skills strategy and potential additional funding through DWP.

## 4. Deferred projects

The group assessed the projects that had been deferred from the previous meeting. The results of the assessments are included in the recommendations.

### 5. Communities & Place Year 3 funding

Funding has been approved for Communities & Place projects in years 1 and 2 only. The group assessed those projects that have been approved to make recommendations regarding continued funding in year 3. The results of the assessments are included in the recommendations.

# 6. Assessment of People & Skills projects

Following the discussion regarding emerging challenges and opportunities, the group decided to defer decisions until the Redditch Skills Strategy is available. Officers were requested to continue conversations with other districts and to develop proposals for countywide programmes. It was agreed that another meeting of the group would take place in July to assess the People & Skills projects with reference to the UKSPF Investment Plan, the Redditch Skills Strategy and the Local Skills Improvement Plans.
