This requirement will be combined with the appropriate options to ensure suitable policy provision.”</u> | Clarity |

| Page 128 | <p>“Option 2 / Option 8 – This policy requirement has been amended to reflect the Worcestershire Transport Assessment Guidelines and Worcestershire Highways Design Guidance rather than the WMRSS Preferred Option Document. This is due to a number of reasons; the Worcestershire Guidance can be updated more regularly, Worcestershire County Council are the Borough Councils Highway Authority and therefore deal with the subsequent Transport Assessment submitted alongside planning applications and the Borough Council are also minded that the Localism Act indicates the WMRSS will be abolished. <u>The WMRSS has been abolished.</u>”</p> | <p>To reflect an updated situation which was previously missed</p> |
