**Matter O2 – Duty to Co-operate & Future Housing Needs from Major Urban Areas**

INSERT:

- O2.1.1 Has Redditch satisfied the Duty to Co-operate with ALL relevant and neighbouring councils, e.g. Stratford?
- O2.3 Has Bromsgrove been able to make an objective, independent assessment under the Duty to Co-operate given they share strategic planning officer duties with Redditch?
- O2.4 With reference to the Birmingham Plan 2031 Duty to Co-operate statement<sup>1</sup>, Bromsgrove requested in their response document Representations on the Birmingham Plan 2031<sup>2</sup> under the heading **Duty to Cooperate Statement page 8-9 Redditch** that the clause *There is a shortage of land within Redditch to meet housing needs arising within Redditch due to its tightly drawn boundary and therefore no potential for it to contribute to meeting Birmingham’s needs* be struckout as it does not mirror the statement on page 5 of BORLP No. 4.  
So can Redditch accommodate additional housing or not?
